

 Samuel H. Smith - (F) 

A witness to the Book of Mormon. Born 13 Mar 1808 in Tunbridge, VT, baptized 25 May 1829 by Oliver Cowdery in the Susquehanna River, one of the six original members of the church, the 1st missionary in the church, on the Kirtland High Council, counselor to the Presiding Bishop of the church, a Bishop in Nauvoo. Always faithful. Died 30 Jul 1844 in Nauvoo, IL.

 Ezra Thayre - (A) 

Born 14 Oct 1791 in Randolph, VT, baptized by Parley P. Pratt in Oct 1830, ordained a High Priest in Kirtland in Jun 1831, Zion's Camp, was the church agent (real estate) in Ohio, High Council at Adam-ondi-Ahman, missionary. Apostatized and joined the RLDS.

 Joseph Wakefield - (A!) 

Born 7 Jul 1792, Died 18 Jan 1835 in Willoughby, OH, Excomm. Jan 1834. Completed a mission with Parley P. Pratt. While on another mission he taught and baptized George A. Smith. After completing this mission he apostatized. Bro. Wakefield reported that he saw Joseph Smith come from translating and go to playing with the children. This convinced Bro Wakefield that Joseph Smith was not a man of God, and the work was false. Bro Wakefield then began to defame Joseph Smith and tried to prove the Book of Mormon was written by Solomon Spalding. He then headed a mob bringing persecution to the saints in and around Kirtland.

 Harvey G. Whitlock - (A) 

*Saw JC & Father
He was seized by James*

Born in 1809, missionary, ordained a High Priest by Joseph Smith at the Morley farm on 3 Jun 1831, saw the Father and the Savior in the Morley schoolhouse. Disfellowshipped in 1834, rebaptized 30 Jan 1836, excommunicated 1838, rebaptized in 1858 in Salt Lake, left the church in 1864 in California. Died in 1874 in Bishop Creek, CA.

John Whitmer - (A*) 

A witness to the Book of Mormon. Born 27 Aug 1802 in Fayette, NY, baptized in Jun 1829 by Oliver Cowdery in Seneca Lake, NY, missionary, was a scribe for Joseph Smith, appointed to act as church historian, called on 3 Jul 1834 as a member of the church Presidency in Missouri. Excommunicated by the High Council in Far West, MO on 10 Mar 1838. Died 11 Jul 1878 in Far West, MO. *He was excommunicated because he was challenged on how he handled some church funds and refused to make a reply to that charged. He offered himself as a hostage at one point to stop the violence towards the Saints. He never denied his testimony of the Book of Mormon.*
